Further, only a person, whose name is recorded in the Register of Members/Beneficial owners as on the cut-off date shall be entitled to avail the facility of e-voting and voting by postal ballot. Members are requested to note that:

- a. Members have the option to exercise their votes either electronically or by way of Physical Postal Ballot.
- The voting both through Postal Ballot and electronic means, shall commence on Monday 12th November, 2018 at 09:00 A.M and shall end on Tuesday, 11th December, 2018 at 05:00P.M.
- c. The duly completed postal ballot forms should reach the Scrutinizer on or before Tuesday, 11th December, 2018 at 05:00P.M.
- d. Any postal ballot received from the shareholders after 05:00 P.M, on Tuesday, 11th December, 2018 shall not be treated as valid and voting whether by Post or by electronic means shall not be allowed beyond the said date.
- e. The e-voting module for voting through electronic means shall be disabled at 05:00P.M, Tuesday 11th December, 2018.

In case, any shareholders casts his votes under both Postal Ballot and electronic mode, then the voting done through e-voting shall prevail and voting done through Postal Ballot shall be considered invalid.
