DECLARATION

Under Section 10(5), Chapter III of the Foreign Exchange Management Act, 1999

- I/We hereby declare that the transaction covered under the credit (the “transaction”), does not involve, and is not designed for the purpose of any contravention of the provisions of the Foreign Exchange Management Act 1999 or of any rule, regulation, notification, direction or order made thereunder. I/We also hereby agree and undertake to give such information/documents as will reasonably satisfy you about the transaction in terms of above declaration.
- I/We also undertake that if I/we refuse to comply with any such requirements or make only unsatisfactory compliance there with, the bank shall refuse in writing to undertake the transaction and shall if it has reason to believe that any contravention/evasion is contemplated by me/us report the matter to Reserve Bank of India. I/We declare and understand that the foreign exchange to be acquired by me/us pursuant to this application shall be used by me/us only for the purpose for which it is acquired and that the conditions subject to which the exchange is granted will be complied with.
- I/We also declare that the transaction does not have linkage with specially designated nations and blocked person (SDN) countries listed under OFAC/UN sanctions in any manner. I/We undertake not to hold CSB Bank responsible for any of its action or inaction in respect of the OFAC-linked/UN sanctioned transactions.
- I/We further declare that I/we shall furnish information relating to this transaction as sought by any authority/government/agency now or later. I/We also authorise to CSB Bank to make available any of the material pertaining to my/our transaction to any authority/agency/entity without referring the matter to me/us.
- We hereby irrevocably and unconditionally agree to indemnify and hold CSB Bank, at all times, fully harmless from and against any and all delays, charges, costs, expenses, claims, liabilities, losses, or penal interest of whatever nature that may arise, result from, or be attributable to the funds being placed on hold, withheld, restrained, or otherwise kept pending by the Nostro banker pursuant to their internal compliance checks or related due-diligence procedures. We further acknowledge that such actions by the Nostro banker are beyond the control of CSB Bank, and accordingly, we undertake that no responsibility, obligation, or liability shall accrue to CSB Bank in relation thereto.
- I/We agree and are bound to comply with all prevailing rules and regulations applicable for this transaction. Further, in case of non-import of goods, we undertake to repatriate the proceeds to India.

- I/We confirm that shipment and/or transshipment of goods covered under this transaction shall not involve any sanctioned countries/territories/parties. I/We are further aware that CSB Bank Ltd may be unable to process any transactions that involves or have linkages/reference to any sanctioned countries/territories/parties including for cases where transshipment is involved.
- I/We confirm that, neither I/we nor this transaction is under any investigation with any regulatory or law enforcing agency.
- I/We hereby declare that the statements made by me/us on this form are true and that I/we have not applied for the same remittance through any other bank.
- I/We further declare that the undersigned has/have the authority to give the above debit authority, declaration and undertaking on behalf of the firm/company.
- I/We hereby agree and confirm that the above Buyers Credit will be utilized for the purpose for which it is being applied for and is subject to the terms and conditions as contained herein and in the agreement entered between applicant and CSB Bank Limited.

a) We understand and confirm that

- Trade credit can be availed subject to maximum prescribed tenor cap as per RBI guidelines i.e up to three years for import of capital goods & up to one year or the operating cycle whichever is less for Non-Capital Goods.
- All-in-cost ceiling should not exceed Reserve Bank of India cap We will ensure that the interest and other charges mentioned in the lending bank quote is within RBI cap.
- Trade credit can be arranged for goods imported directly into India hence it cannot be arranged for advance remittances and trade pertaining to services.
- BG/SBLC can be issued only in favour of overseas lender.
- Trade credit can be arranged for maximum USD 50 million per shipment.
- In case the goods to be imported are capital in nature, we confirm that the goods are capital goods as defined in the Foreign Trade policy issued by DGFT from time to time.
- CSB Bank Limited may have to share our financial data with overseas bank funding this Buyers Credit and we do not have any objection for this.
